All materials submitted to the Office of Congressman Gil Cisneros will not be returned to the applicant. Any applicant package received by October 31, 2025, will NOT be considered. SAT/ACT scores for the October testing dates are the only materials accepted after the deadline. You will receive an acknowledgment once your application has been processed.

 - 4) One Non-Academic Recommendation.
 - 5) Candidate Fitness Assessment Scores.
 - 6) Interview Request Form.
