### To apply for your U.S. passport, you must:

- Submit your completed application, [DS-11](#), to request the Passport Book, Passport Card, or both; or submit the Renewal form, [DS-82](#), to renew your passport. The application forms DS-11 and DS-82 can be downloaded from our website: [travel.state.gov](https://travel.state.gov).
- Submit your original evidence of U.S. Citizenship:
  - A certified copy of your birth certificate;
  - An original Certificate of Naturalization or Citizenship;
  - Original Report of Birth Abroad; or
  - Previously issued, undamaged, U.S. passport.
- Bring a photocopy of your evidence of U.S. Citizenship
- Submit one recent Passport Photo—2 inches x 2 inches. **NO GLASSES** in Photos.
- Present Valid Photo Identification—Driver's License, State issued ID Card, current passport or Military ID and submit a photocopy of the front and back of that ID.
- Payment of passport fee by credit/debit card, check, or money order.

**U.S. Passport Book:** Used for international travel by land, air, and sea.

**U. S. Passport Card:** Used for entering the United States at land border crossings and sea ports-of-entry from Canada, Mexico, the Caribbean and Bermuda. **Not valid for international air travel.**

**Validity of Books and Cards:** 10 years for adults (ages 16 and older)  
5 years for minors (under age 16)

**Processing Times by mail:** Routine - 4-6 weeks  
Expedited - 2-3 weeks and an extra \$60 fee.

Passport applicants must appear in person, including minors. Passport applications for minors under 16 require the consent of **both** parents, or evidence that one parent has sole legal custody. <b>1-3 Day Delivery</b>	Paid per application for 1-3 day delivery of an issued passport book from the Department of State to the customer. Only applies to mailing addresses within the United States. 1-2 day delivery is not valid for passport cards.	<b>\$22.05</b>
<b>File Search Fee</b>	A file search is necessary when an applicant is unable to present evidence of U.S. citizenship or verification of a previously issued U.S. Passport or Consular Report of Birth Abroad. Applicant must submit Form DS-11 and written request for a file search.	<b>\$150</b>
